Val Lloyd: The final new petition is regarding a care home in Seven Sisters in the Neath valley. It is an e-petition—which received 1,700 signatures—and a traditional paper petition from Mr Gary James in Seven Sisters. He calls upon the National Assembly for Wales:

'to examine the circumstances surrounding the proposed siting of a Castle Care home at...Dulais Road, Seven Sisters, Neath'.

Kirsty Williams: The petition has been put together very well, but the petition states as fact things that I believe you could only surmise. So, it would be interesting to hear from the people who have gathered this petition together to test some of the assertions that they make in the petition. It might also be useful to hear from the Minister for Social Justice and Local Government to see what the Government's views are on the provision of this type of service. My understanding is that this would be a decision for a local authority planning committee, so we must be careful that we do not subvert the natural progress of a planning application. However, it would be useful to hear from the Minister about the policy context in which a planning application may be submitted, so I would ask to see the petitioners to give them an opportunity to air some of their concerns and to test some of the assertions that they have made in their petition, and to hear from the Minister, if that is acceptable.

Val Lloyd: I agree in principle, but would it be wise to get a ministerial view first and then have the petitioners in?

Kirsty Williams: Yes, and we would also have to be careful with the status of this application, because if we take a view on it, that bit might be prejudicial to any planning process, and I do not think that it is the Petitions Committee's job to intervene in a local government planning process. It would not be appropriate.

Val Lloyd: Perhaps we should contact Neath Port Talbot planning authority. Perhaps we should make a call or send an e-mail to check the status of this before we consider it and, at the same time, get a view from the Minister.

Andrew R.T. Davies: I concur. We have taken a very firm line on planning applications. In our early days, we had to consider whether one or two petitions that came through were in the planning ball game or outside it. We need to ascertain whether this is a live application and get the ministerial view too. We should tread very carefully if it is a live planning application; we should adhere to our principle of not getting involved with it.

Val Lloyd: We are all agreed on that, then. So, we will get a view from the Minister and, at the same time, we will establish exactly where the planning issue lies at the moment.

Val Lloyd: The next petition relates to Castle care home. We first discussed it in June and we have now had a reply from Jane Davidson, the Minister for Environment, Sustainability and Housing. Basically, we are told that we should

advise the petitioners to address their concerns to the local planning authority once the planning application is on the table. Are there any views on this? I do not think that we can do anything more than advise the petitioners that they will have an avenue to influence the planning department and that they should be alert to the advertisement appearing in the press, or they should forewarn the Neath Port Talbot planning department that they would like to know if a planning application came in.

Mr Davidson: I am sorry to interject again, but I have very recently received correspondence from the petitioner. I understand that the planning application has been approved by Neath Port Talbot County Borough Council. However, as this is a local authority decision-making process, the committee would not get involved, and the petitioner is pursuing this via the local authority's complaints procedure.

Andrew R.T. Davies: We have always erred on the side of caution when it comes to planning applications and planning issues, because, in the first instance, they are within the remit of local authorities. I thank the clerk for his update, but I do not think that we can do much more on the petition, so we should close it.

Val Lloyd: I do not think that there is more that we can do, so we will close it. The petitioners are obviously aware of the information that we were going to give them.

Dear Val,

Thank you for your letter and enclosures of 17 June 2008 addressed to Brian Gibbons AM, which has been passed to me for a response in my capacity as Minister for Environment, Sustainability and Housing.

I am advised by both Brian Gibbons AM and Edwina Hart AM that their Departments do not provide any specific guidance for local authorities on the siting of care homes.

However, Planning Policy Wales (March 2002) sets out national planning policies that must be taken into account when determining planning applications. Care homes are not specifically referred to, as issues of sustainability and amenity are adequately dealt with in national policy on a generic basis.

Chapter 4 in particular sets out policy on making planning decisions. It explains that the planning system does not exist to protect the private interests of one person against the activities of another and that proposals should be considered in terms of their effect on the amenity and existing use of land and buildings in the public interest. It is for the local planning authority to come to a view on this application as they can best judge current provision and any further demand for services.

Welsh Ministers are unable to comment on specific planning applications, as to do so may prejudice any formal role they may have should the development subsequently come before them under their various planning responsibilities. Any comments made in this letter are therefore in respect of general Welsh Assembly Government policies or specific non-planning issues, and are without prejudice to the Welsh Ministers' consideration of the planning application, if the Welsh Ministers are to subsequently decide it.

It is for the residents to make their concerns known to the local planning authority, to inform their decision.

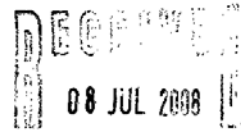
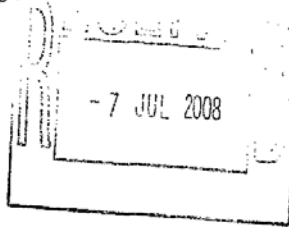
