  - (b) to promote the use of sustainable modes of travel when exercising functions under this Measure, and
  - (c) to make travel arrangements for learners with special educational needs.
- ( ) The report under subsection (1) must describe the extent to which the steps taken appear to have been successful.'

The Welsh Ministers must, at least once in every calendar year, lay before the Assembly a report setting out –

- (a) the steps taken by them during the period to which the report in relation to the implementation of this Measure;
- (b) the way in which local authorities have complied with their duties under this Measure; and
- (c) when they have asked the Chief Inspector of Schools to give advice to them under section 20(2)(a) of the Education Act 2005 on a matter relating to the extent to which the duties under this Measure are being discharged effectively, the advice which they have received from the Chief Inspector during the period to which the report relates.’.
